PARTY RULES AND REGULATIONS

RESERVATIONS: All reservations and arrangements for the use of Museum facilities must be made two weeks in advance. Party reservations will be confirmed with the completion of this contract, a **\$100 deposit** and the signature of the adult hosting the party. Deposit is deducted from the **total balance** the day of the party. **Deposits for canceled parties are non-refundable. Deposits are transferable to another open date with two weeks advance notice.**

Parties are available for scheduling five days a week. Accommodations for different party times can be made depending on the Museum schedule and with authorization from administration. Parties are scheduled for 2 hours. **If the party exceed thirty (30) minutes past the hour in which the party is scheduled to be completed, you will be charged for the extra hour (\$100).** Parties will finish at the time stated on the contract, regardless of the time the party host or guests arrive. If a scheduled extra hour is not desired after reservation is made, please call within 2 weeks of party date to cancel the hour. **Otherwise, Museum staff is required to charge the fee (\$100) on the day of the party.**

Guests are welcome to bring in a clown or any other character for the party. **Outside sound systems are not allowed in the Museum.** You may ask the party host to play music, if it is appropriate for the children's museum.

PARTY DAY: Museum employees are trained to follow a suggested schedule to better serve you. Party Hosts may come in 1 hour before the party is scheduled to begin decorating. Party guests will not be admitted to the party until 15 minutes before the party is scheduled to begin. Otherwise, regular admission fees will apply.

The back door to the Museum may be used for loading and unloading party supplies ONLY, as per Fire Code and mall regulations. Party guests are not allowed to exit through the back door under any circumstances. All party guests must enter through the front door in the mall and sign in at the front counter.

The Imaginarium of South Texas will not provide or allow extra tables and chairs in the party area. If the number of guests exceeds the limit set forth by the Imaginarium of South Texas, staff may not accommodate space for eating or sitting. As per the Laredo Fire & Safety Hazard rules, the Imaginarium of South Texas is required to set a limit on the number of tables and chairs authorized to be in the party area without compromising the safety of our guests. Under no circumstances may the Imaginarium of South Texas staff or guests add tables or chairs to the party area.

All food must remain in the designated area. **No food is permitted outside the party area.** Any food found outside area will be thrown away. **As per the Laredo Health Department, all food must be purchased from a licensed vendor- including all cakes, snacks, and candies.** The Imaginarium recommends that you bring a receipt for all food at your party if the Health Department checks your party. **All food sitting out for more than 30 minutes will be thrown away to prevent food poisoning. For safety reasons, no sparkle candles, no fireworks, no gas propane tanks, generators, or any piece of equipment that can compromise the safety of our guests will not be allowed into the Imaginarium. The Imaginarium of South Texas reserves the right to decide what piece of equipment may pose a safety issue.**

PARTY FEES:

Members pay \$8 per child and \$4 per adult.
Non-Members pay \$10 per child and \$5 per adult.

There is a minimum charge of 15 children for all parties. All persons attending the party will be charged, including parents and siblings except the birthday child. Uninvited children are the responsibility of the Parent. Please specify on your invitation if you wish to restrict your guest list. Supervision of party guests is a shared responsibility between Museum Staff and Party Hosts. **Please settle party contract total at least 15 minutes prior to the end of your Birthday Party.**

IMPORTANT INFORMATION – SUPERVISION AND RESPONSIBILITIES:

All museum visitors are responsible for the supervision of their own children. **Adults attending parties must ALWAYS accompany their children.** Parents are responsible for their children *AT ALL TIMES*. Parents are asked to stay with their children until the party is over. Adults must stay inside the Museum at all times. Parents who drop off their children for a drop-off only party must drop off their children with the Party Parent/Host/Hostess. Museum Staff serve as greeters and assist Party Hosts. Ultimately, **care of ALL party guests is the responsibility of the parent Party Host/Hostess.**
